The Government of Nepal **has allocated funds** towards the cost of **Construction Of Prestress Bridge** on Khalinjor Khola, Lalbandi Municipality ward No.15 and intends to apply part of the funds to cover eligible payments under the Contract **for** NCB/32/2076/077. Bidding is open to all eligible Nepalese Bidders.
2. Lalbandi Municipality, Lalbandi, Sarlahi invites electronic bids from eligible bidders for the **Construction of Prestress Bridge** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs.14.0 Crores**
- Minimum Work experience of similar size and nature: **2 Prestress Bridge with Pile Foundation, value of each to be Not Less Than NRs. 13.5 crores within last 10 Years.**

6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on 2077/01/05 at the office of Lalbandi Municipality, Lalbandi Sarlahi. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs 50,00,000.00** which shall be valid for 30 days beyond the validity period of the bid.
