- Bids shall be opened in the presence of Bidders' representatives who choose to attend at 14:00 hour on (31st day from first day of notice published) at Lalbandi Municapility, office of Municipal Executive, Lalbandi Sarlahi. Non-attendance of any or all of the Bidders' representatives shall not hinder the opening of the bids. Bids must be valid for a period of as mentioned in table below after the date of bid opening.
  Bids must be accompanied by a Bid Security of minimum amount specified in table below either in the form of
- bank voucher confirming cash deposit in deposite account no.as specified above or a bid security (unconditional bank guarantee) issued by Commercial Bank as approved by Nepal Rastra Bank. The Bid Security shall be valid for 30 days beyond the bid validity period. Bidder must clearly quote the contract name and contract number in Bid security form(Bank guarantee) otherwise will cause disqualification of Bidder.
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case, the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- B. Bidders can bid as a single contractor or in the form of Joint Venture of maximum of three contracting firms.
