Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid,\amounting to a minimum of NRs 13,50,000, which shall be valid for 30 days beyond the validity period of the bid.
